Three other torts designed to protect an interest in land: Trespass, The Rule in Rylands v Fletcher, and Negligence GROUND FOR LIABILITY Appleby v Erie Tobacco o (1910), 22 OLR 533 (Div Ct) RATIO: A nuisance has to materially interfere with the landowner or occupier's ordinary comfort (Materiality) We must balance this standard against any
